

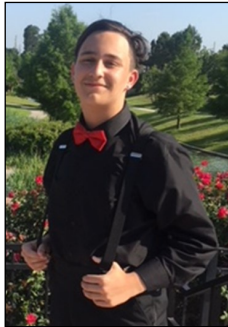

Father's Day is celebrated by Americans on the third Sunday in June. This year the date falls on Sunday, the 17th of June.

Contrary to popular belief, this is not a holiday that was thought up as an ad campaign by a popular card company. There are, however several events which may have inspired the idea of Father's Day. One inspiration was the observance of the Mother's Day tradition in the first decade of the 20th century, while another belief is that it was originally a memorial service held for a large group of men, many of them fathers, who were killed in a mining accident in West Virginia in December 1907.

Most people agree Sonora Smart Dodd was an influential figure in the establishment of Father's Day. Her father raised six children by himself after the death of their mother. This was uncommon at that time, as many widowers placed their children in the care of others or quickly married again.

Sonora was inspired by the Mother's Day celebrations and felt that her father deserved recognition for what he had done.

The first time Father's Day was celebrated in June was in 1910. Father's Day was officially recognized as a holiday in 1972 by President Nixon. Although not a federal holiday, this special date is set aside to acknowledge and honor fathers everywhere.

So take advantage of this special day and wish a Dad a Happy Father's Day.

Minutes of the Board Meeting

May 7, 2018

The General Session of the Enchanted Valley Homeowners Association monthly Board meeting was held on the above date at the Enchanted Valley Clubhouse located at 14910 Enchanted Valley Drive, Cypress, Texas, 77429.

Absent:**CALL TO ORDER**

Director Coker called the meeting to order at 7:00 pm.

GUESTS TO ADDRESS THE BOARD

Several owners addressed their concern on changing pool hours. Director Coker stated the hours changed based on low usage during hottest part of the day. He asked owners for their recommendation on hours of operation and majority want the pool open 10am-8pm. The Board agreed to extend hours depending on increase in cost for extra hours and lifeguards. Director Nickerson Motioned to approve if budget has funds to extended hours. Director Spies seconded the motion. All were in favor.

Discussion continued with owners reporting various topics (home on Earlywood Lane is in poor condition and is being reported to the Board of Health, how to address dog waste at the park, pot belly pig pet being kept in backyard, tennis court resurfacing and lighting and neighbors burning trash in backyard).

Shane Shoaf gave an update on swim team schedule and reported power outlet by water fountain not working, the need for a defibrillator and updated first aid kit at the pool, gate at guard shack has broken anchors, pool party options and someone is removing swim team and other signs without permission.

MINUTES

Director Robinson motioned to approve the March 5, 2018 minutes as corrected. Director Tips seconded the motion. All were in favor.

COMMITTEE REPORTS

Neighborhood Events Committee: July 4th parade and picnic Director Nickerson will cook.

Landscaping Committee: Texas Red bids reviewed. Director Nickerson suggested for pool landscape a smaller number of plants can be purchased for around \$300. Director Robinson motioned to approve an \$850.00 maximum limit for the landscaping. Director Tips seconded the motion. All were in favor. Get bid to trim tree by flagpole before July 4th. Ask Texas Red to revise landscape maintenance bid with new frequency schedule. Yard of the Month has resumed. Get cost for repainting curb address numbers at homeowner's expense.

Pool Committee: Get cost to change 2018 pool hours to 10am-7pm or 10am-8pm.

Communications Committee: Post notice on website to join Next Door with disclaimer SCS Go is the official site of Enchanted Valley HOA.

Ms. Norris presented the April Management Reports and a brief discussion followed.

MESSAGE FROM THE SUPERINTENDENT



May 25, 2018

Dear Parents & Community Members,

The last week has presented some challenges for educators as we evaluate our school safety protocols and seek ways to strengthen security measures. Many of you have sent me questions and concerns via email, and I appreciate the feedback as we work together to better protect CFISD students and staff.

In light of two major school shootings since February, I have already started meeting with district leadership and law enforcement officials to review current procedures and discuss potential changes for the 2018-2019 school year.

I continue to stress how fortunate we are in CFISD to employ approximately 100 well-trained, professional police officers who work diligently 24/7 with every campus to provide a variety of safety measures to prevent what occurred in Parkland, Fla., and Santa Fe, Texas. Besides being available to respond in the time of a crisis, CFPD officers provide many proactive measures, such as investigating all potential threats, monitoring social media and tip line reports, making home visits, mentoring students and providing classroom presentations.

We will continue to look at ways to enhance our campuses in order to make them even safer. We ask for everyone's patience, understanding and support as we make modifications to practices and procedures for how our students, staff, parents and community members access our campuses next school year.

As always, we encourage use of the [tip line](#) and if you hear or see something, say something. While no plan is perfect, we will all have to work together as a team to keep our campuses as safe as possible.

FLAG DAY



Flag Day marks the adoption of the flag of the United States which happened on June 14, 1777, thanks to a resolution of the Second Continental Congress. Known as the Stars and Stripes, the resolution stated: "Resolved, that the flag of the United States be thirteen stripes, alternate red and white; that the union be thirteen stars, white in a blue field, representing a new constellation." As the exact arrangement of the stripes and stars was not specified, individual flag makers used their own judgment, which, naturally, resulted in several variations. Over the years the configuration has changed to accommodate the new states joining the Union.



Which brings us to the present. President Eisenhower's Executive Order of August 21, 1959, provided for the arrangement of the stars in nine rows of stars staggered horizontally and eleven rows of stars staggered vertically.

The Stars and Stripes is the national and merchant flag and ensign (flag, or standard, especially a military or naval one indicating nationality) of the United States of America with thirteen stripes (seven red and six white) of the first Union and 50 stars representing the fifty states of the union.
